Dear Madam,

- 1. We have reviewed the result of National Cereals Products Limited ("the Company") for the quarter ended June 30, 2014 ("the Statement"), except for the disclosures regarding 'Public Shareholding' and 'Promoter and Promoter Group Shareholding' which have been traced from disclosures made by the Management but have neither been reviewed nor been audited by us. The statement has been prepared by the Company pursuant to Clause 41 of the Listing Agreement with the Stock Exchanges in India, which has been initiated by us for identification purposes. This Statement is the responsibility of the Company's management and has been approved by the Board of Directors. Our responsibility is to issue a report on the Statement based on our review.
- 2. We conducted our review of the Statement in accordance with the Standard on Review Engagements (SRE) 2410, "Review of Interim Financial Information Performed by the Independent Auditor of the Entity" issued by the Institute of Chartered Accountants of India. This Standard required that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatements. A review is limited primarily to inquiries of Company personnel and analytical procedures applied to financial data and thus provide less assurance than an audit. We have not performed an audit and accordingly, we do not express an opinion.
- 3. (i) Deferred tax assets/ liabilities for the quarter ended June 30, 2014, required to be accounted for in terms of Accounting Standard (AS) 22 "Accounting for Taxes on Income" notified under the Companies (Accounting Standards) Rules, 2006 has not been determined or accounted for the by the Company, and therefore, its effect on results for the quarter ended June 30, 2014 and earnings/ (losses) per share has not been determined. (Refer note (iii) of the accompanying statement)
 - (ii) The impact of Accounting Standard (AS) 15 "Employee Benefits" (Revised) issued by the Institute of Chartered Accountants of India has not been determined and accounted for the by the Company. Therefore its effect

Based on our review conducted as stated above, except for the matters referred to in paragraph 3 above, nothing has come to our attention that causes us to believe that the accompanying Statement, has not been prepared in all material respects in accordance with the applicable Accounting Standards notified pursuant to the Companies (Accounting Standards) Rules, 2006 as per Section 211 (3C) of the Companies Act,1956, read with General Circular 15/2013 dated 13th September 2013 of the Ministry of Corporate Affairs in respect of Section 133 of the Companies Act 2013 and other recognized accounting practices and policies, has not disclosed the information required to be disclosed in terms of Clause 41 of the Listing Agreement with the stock exchange, including the manner in which it is to be disclosed, or that it contains any material misstatement.
- 5. Further, we also report that we have traced the number of shares as well as the percentage of shareholding in respect of the aggregate amount of public shareholding and the number of shares as well as the percentage of shares pledged/encumbered and non-encumbered in respect of the aggregate amount of promoters and promoter group shareholding in terms of Clause 35 of the Listing Agreement with the Calcutta Stock Exchange and the particulars relating to undisputed investor complaints from the details furnished by the Management and therefore not expressing our review opinion thereon.
